I understand and acknowledge that this Release discharges Habitat from any liability or claim that I may have against Habitat with respect to any bodily injury, personal injury, illness, death, or property damage that may result from Habitat participation. I also understand that Habitat does not assume any responsibility or obligation to provide financial assistance or other assistance, including but not limited to medical, health, or disability insurance in the event of injury or illness, death or property damage. I hereby release and forever discharge Habitat from any claim whatsoever which arises or may hereafter arise on account of any first-aid treatment or other medical services rendered in connection with an emergency during my time with Habitat.

**Assumption of the Risk.** I, the volunteer understand that the my time with Habitat may include activities that may be hazardous to me, including , but not limited to, construction, loading and unloading and local transportation to and from the work sites. So I recognize and understand that my time with Habitat may, in some situations, involve inherently dangerous activities. I hereby expressly and specifically assume the risk of injury or harm in the activities and release Habitat from all liability for injury, illness, death, or property damage resulting for the activities my time with Habitat.

**Photographic release.** I grant and convey unto Habitat all rights, title, and interest in any and all photographic images and video or audio recordings made by Habitat during my work with Habitat, including, but not limited to, any royalties, proceeds, or other benefits derived from such photographs or recordings.

**Other.** I expressly agree that this Release is intended to be as broad and inclusive as permitted by the laws of the State of Florida, and that this Release shall be governed by and interpreted in accordance with the laws of the State of Florida. I agree that in the event that any clause or provision of this Release shall be held to be invalid by any court of competent jurisdiction, the invalidity of such clause or provision shall otherwise affect the remaining provisions of this Release which shall continue to be enforceable.
